The Fourth Presbyterian Church of Chicago 2006 Annual Report

Dear Friends.

It has been more than twenty years since I walked through the doors of this wonderful institution as its pastor, and there has not been a day in those years that I have not experienced a sense of wonder and deep gratitude for the great privilege of it. It's how I begin every Sunday. I like to walk the several blocks between home and Fourth Church early Sunday morning. The sidewalk is



mostly empty except for an occasional runner or walker or early-rising hotel guests sipping Starbucks while in search of a newspaper. The sanctuary doors are already standing open: ushers and house staff are making final preparations for the 2,000 or so people who will come to worship during the morning. No detail is too small: the tiny panes of glass in the narthex

doors are cleaned and polished; hymnals and Bibles are straightened and arranged in a precise alternating pattern in each pew rack; bulletins are in their assigned location; roses in the chancel are placed in their vase; water glasses behind the lectern are filled; organists are going over the morning's program and rehearsing the opening hymn. For me it is a private moment of gratitude and wonder, a call to worship and to the day's—and week's—busy mission. I often think to myself, "This is the day the Lord has made! Let us rejoice and be glad in it."

I'm writing on the last day of 2006 and thinking about what a good and important year it has been in the life of the Fourth Presbyterian Church of Chicago. We added two gifted Associate Pastors to our staff: Adam Fronczek in Adult Education and Worship and John Vest in Youth Ministry. Both Adam and John have made easy transitions into the life of Fourth Church and are already making major contributions. Ali Trowbridge returned from maternity leave after the birth of daughter Lilly to

assume responsibility for Congregational Care. Elizabeth Andrews moved to a part-time position of Parish Associate to work with Ali, and Joyce Shin, who was an intern here years ago and is in the PhD program at the University of Chicago, stepped in to help out with Congregational Activities. These additions bring the staff close to full strength, and the particular mix of these gifted colleagues makes coming to work a true joy. Dana Ferguson's strong and graceful leadership as Executive Associate Pastor is a real gift, as is the steady and faithful ministry of Calum MacLeod in Evangelism, Donna Gray in Children's Education, and Keith Harris in Community Ministry. Tom Rook and John Boyle, Parish Associates, provide additional pastoral care and leadership. Tom Schemper (Counseling Center), John Sherer (Music and Organist), Ann Rehfeldt (Communications), Lisa Radetski (Giving Ministries), and Beth Truett (Chicago Lights) complete the Program Staff, and each brings expertise, wisdom, and a lively personal faith to our common ministry. After a decade as my Executive Assistant, Judi Simon retired in August and moved, with husband Marc, to Moab, Utah. Barbara Cleveland, happily, is my new assistant. Barbara brings a wealth of skills and a deep understanding of and love for the church to her job. I could not be happier.

Several highlights of the year for me were—

- The two-week residency of Professor Walter Brueggemann, distinguished theologian and biblical scholar, in May and June. Walter preached twice and delighted and inspired large audiences with a series of lectures in Anderson Hall.
- The public lecture and reading by poet and author Wendell Berry, one of my favorite writers. The presence of Brueggemann and Berry were special gifts to me on the twentieth anniversary of my ministry here, an honor for which I am deeply grateful.

- Dave Brubeck brought his quartet back to Fourth Church and presented a stunning concert of classical jazz and, with our Morning Choir, his own compositions of sacred music.
- Our mission outreach programs continued to serve our neighbors and, just as importantly, to make a visible witness to the world about what Christian faith is all about, a witness in sharp contrast to what the world sees and reads in the media about Christianity. In addition to these Fourth Presbyterian Church projects, we are involved globally in an AIDS clinic in Cameroon, Habitat for Humanity in Honduras, and mission work trips to New Orleans, Guatemala, the Pine Ridge and Rosebud Indian Reservations, and Cuba. We continue to support the worldwide mission of the Presbyterian Church (USA), the Synod of Lincoln Trails, and the Presbytery of Chicago and the work of various mission partners locally, nationally, and globally. Mission represents 40 percent of our budget, approximately \$3.6 million.

One of the most important activities during the year was one of the least visible. The management of this wonderful church is complicated, to say the least. Church budgets are built not only on missional aspirations but also financial realities, including income from invested funds, bequests and gifts, special offerings, program fees, and, the largest component, pledges and contributions. A special Financial Planning Task Force was assembled to evaluate our operations, budget processes, to make projections about future income and spending needs and to present recommendations to the Session and Board of Trustees. We put some of the best financial minds in the congregation to work on the project, and they have produced a very helpful and long-reaching report. Included are budget projections and disciplines going forward and a strong recommendation that we do a better job of communicating financial needs and realities of the church to all of our members. We began

to do that during the year with positive results, and we will continue. Our goal is for every one of our 5,771 members to know what our church is doing and to participate in its support with a generous and faithful pledge.

In the meantime, we continue to anticipate the expansion of our facilities and the strengthening of Fourth Church for the future through the goals of Project Light. Wonderful sanctuary improvements were accomplished during the year: a new floor, new pews fabricated and installed, and a new sound system that also includes an induction loop to augment hearing devices, in addition to exterior lights and repairs. The sanctuary is now compliant with the requirements of the Americans with Disabilities Act. We fully anticipate resolution in the next year to building plans to provide desperately needed new program and mission space.

What an amazing institution this is. What a privilege it is to be part of it all!

P. S. A note about our Christmas Eve broadcast in 2006: For the past four years, our 8:30 p.m. Christmas Eve Candlelight Service

past four years, our 8:30 p.m. Christmas Eve Candlelight Service of Lessons and Carols has been televised on CBS Channel 2 at 10:35 p.m. on Christmas Eve and again on Christmas morning. In 2005, a huge trailer loaded with equipment was parked in the church lot during the day of the 24th as cables were assembled and placed throughout the sanctuary and television cameras were stationed on the chancel floor and balconies. A Channel 2 crew worked that entire day setting up, expertly taped the 8:30 p.m. service and broadcast it at 10:35 p.m. that night. In 2006, however, because the 24th was a Sunday and the sanctuary was in use from morning till night, the necessary technological preparation could not happen that day. So Channel 2 suggested that we rebroadcast the Christmas Eve 2005 service. We agreed, announced for weeks in advance that was what we were doing, and also announced at the head of the program "This is a rebroadcast of the December 24, 2005, service."

I knew it didn't work when my son-in-law tuned in to Channel 2 on Christmas Eve and said to my daughter, "Your father must be losing it. He's telling the same stories he told last year."

So if you are wondering or if you are asked: the 2006 Christmas Eve and Christmas Day broadcasts were indeed a rebroadcast of the 2005 service.

Celebration and Gratitude for Faithful Giving

We are deeply grateful for generous and faithful giving and pledging by members and friends of Fourth Presbyterian Church.

Thank you to all those who fulfilled 2006 pledges. Members and friends who have not fulfilled last year's pledges are urged to do so: at year end, more than 10 percent of 2006 pledges were unfulfilled. Not only does this create significant monetary challenges for the church, but it greatly inhibits the ability of church leaders to plan a budget based on pledges being honored. Each and every dollar pledged and received by the church makes a difference in the ministry and work of the congregation.

Thank you to all who made a pledge for 2007, particularly to the 461 households who raised their pledges and to the 211 households who made a pledge for the first time. The Stewardship and Giving Committee is working hard to increase the percentage of our members who support the church on a regular basis. While there are still 300 households who pledged in 2006 and have not yet renewed, compared to last year at this time participation has increased by 18 percent.

Thank you to everyone who has helped Fourth Church reach an all-time high of \$2.98 million in pledges, bringing the 2007 Stewardship campaign ever closer to the goal of \$3 million.

We are also profoundly grateful for those who made special year-end gifts and for an extraordinarily generous gift of \$500,000, which will enable Fourth Church to move into the new year with a responsible and balanced budget.

And so it is that Fourth Presbyterian Church will continue to serve our members and neighbors as a "Light in the City." **Thank you to all!**

The Boards

The belief that the people of God are called to be leaders is at the heart of the Presbyterian way. This commitment manifests itself in a style of "representative democracy" that is unique in the worldwide church. This representative democracy is embodied in the boards of the church: the Session, the Board of Trustees, and the Board of Deacons. The officers who serve on these boards have been identified for their gifts of leadership and commitment to the life and ministry of this congregation and are elected to three-year terms by the congregation. These elections are held each February. Officers are then ordained and installed in May, when they begin their term of service. This report gratefully acknowledges all those who served as officers during 2006: those whose term ended in May, those whose term began then, and those whose term continued throughout the year.







Fourth Church concludes its commemoration of the twentieth anniversary of John Buchanan's ministry in Chicago by hosting an evening with poet, essayist, and novelist Wendell Berry. On October 4, Berry delights the large crowd with readings of some of his most recent poems, from 2005 and 2006, and the short story "The Requirement."

The Board of Deacons

The Board of Deacons is often called "the heart of the church." Deacons are responsible for the care of the congregation and outreach ministries. Each Sunday they staff the volunteer table during Coffee Hour, provide intercessory prayer in Stone Chapel after 11:00 worship, conduct a tour of the church, and welcome visitors to the narthex on Sunday afternoons.

The theme "Faith in Community" has provided the foundation upon which current Deacon programming has been developed. Special speakers have illuminated this theme for the board: Cynthia Campbell, President of McCormick Theological Seminary, offered highlights from the General Assembly of the Presbyterian Church (USA), and Homer Ashby, Professor of Pastoral Care at McCormick, spoke on vocation. The Deacons continue to live out their ministry through their help with Sunday Night Supper at Fourth Church, the Deacon-initiated Monday Night Supper at Catholic Charities, and Youth Tennis Camp. Enhancements to their fellowship opportunities have included a dinner prior to their meetings and working together on a Deacons plot at the Chicago Avenue Garden. Two significant new initiatives have been (1) a focus on "Protecting God's Creation," which has included working with other Fourth Church programs to host a screening of An Inconvenient Truth and an Academy class on ecology and theology and installing more energy-efficient lighting in the







The Session

The Session, which is the governing body of the church, is made up of thirty-seven Elders (the translation of the Greek word *presbyteros*). The Session is responsible for the whole life and ministry of Fourth Presbyterian Church.

Particular Session responsibilities include receiving new members; leading the congregation in mission; providing for worship and the administration of the sacraments—baptism and communion; offering educational programs, care and nurture, and fellowship opportunities; and challenging the congregation in its stewardship of time, talent, and financial resources.

Included in the work of the Session in 2006, and in collaboration with the Trustees,

was a commitment to invest in the Middle East. As a result, Fourth Church set aside one percent of its invested funds to make a positive difference in Israel and the Palestinian territories. It invested a portion of that in five Israeli companies and committed \$20,000 to UNICEF for its work in relief for Palestinian children. The Session also continued its ongoing and wide-ranging work in the mission and ministry of this congregation, carrying out its responsibilities through the several committees that report to the Session. Adult Education

The Adult Education Committee provides for the education and spiritual growth of Fourth Church members and visitors through the Academy for Faith and Life, Bible study groups, officer training, Michigan Avenue Forums, the Borden Library, tape and transcript ministries, and educational collaboration with other church programs.

This year, the committee has been examining how it might broaden its audience and share its resources by experimenting with different teaching methods and schedules and working cooperatively with other Fourth Church programs. One example is the "Wrestling with Scripture" class, led by Adam Fronczek, which gave participants an opportunity to study the Bible in small groups facilitated by pastoral residents. The curriculum was shared with the Young Adults group later in the fall and will be a part of other educational offerings in 2007.

The Adult Education Committee also makes arrangements for a variety of additional opportunities for education at Fourth Church. Bible study and book groups gather throughout the week, and special events with outside speakers continue to bring top minds to the community. Novelist, poet, and essayist Wendell Berry and theologian Harvey Cox each gave presentations to large gatherings in the sanctuary. An educational highlight of 2006 was Walter Brueggemann's visit during the month of June as Theologian in Residence. Dr. Brueggemann's morning and evening lectures attracted hundreds of members and guests and provided great fodder for discussions throughout the year.



Education and Worship and Associate Pastor for Youth Ministry

After a thorough and thoughtful search, the Adult Education and Worship Associate Pastor Nominating Committee recommended Adam Fronczek to the congregation on Sunday, March 12. He was enthusiastically elected by the congregation that day and joined the Fourth Church staff in mid-May. On Sunday, July 23, he was installed as Associate Pastor for Adult Education and Worship during the 11:00 service.

On Sunday, June 11, the Youth Ministry Associate Pastor Nominating Committee presented the results of their hard work, recommending John Vest as a candidate for Associate Pastor for Youth Ministry. He too was enthusiastically received and elected by the congregation. He began his work with the Fourth Church youth in July and was both ordained to the Ministry of Word and Sacrament and installed as Associate Pastor during Vespers on Sunday, October 15.

At a congregational meeting held on Sunday, October 22, the congregation heard that Ali Trowbridge, who had been on maternity leave from her position as Associate Pastor for Congregational Life, would be returning as Associate Pastor for Congregational Care, a role that Elizabeth Andrews had been filling on an interim basis after Carol Allen's retirement. (Elizabeth has since joined John Boyle and Tom Rook as a Parish Associate.) Consequently, the congregation voted to request that the Presbytery of Chicago establish an additional Associate Pastor position for Fourth Church, one that would be filled by a new Associate Pastor for Congregational Life. The congregation then elected an Associate Pastor Nominating Committee consisting of Kathryn Dutenhaver, Elinor Hite, Jerry Latherow, Sylvia Robertson, and Rick Sabol to search for a candidate once Presbytery approval of the position was received. The committee plans to recommend to the congregation in 2007 a candidate for Associate Pastor for Congregational Life.

Chicago Lights

The Board of Chicago Lights has oversight for the financial and programmatic effectiveness of the Center for Older Adults (now Center for Life and Learning), Center for Whole Health, the Elam Davies Social Service Center, Tutoring and Scholarship, Summer Day, and Near North Magnet Cluster. Operating as a 501(c)(3) nonprofit organization supporting Fourth Church, Chicago Lights continues the legacy of the church's service to its urban neighbors.

During 2006, the board oversaw the implementation of the Center for Whole Health's Near North Healthy Heart project for women in Cabrini-Green; the completion of a long-range planning process for the Center for Older Adults (COA); and the growth of youth development projects for Tutoring and Scholarship students. They also helped the Elam Davies Social Service Center and Fourth Church take a leadership role in Interfaith Homes, a collaboration with the City of Chicago and Interfaith Council for the Homeless to move families from homelessness to being housed and independent. Throughout the year, the board increased the visibility of Chicago Lights among Fourth Church members and attracted new foundation and corporate funders, while early in the year they oversaw a Mission Benefit that exceeded results of all previous years. They helped to close the digital divide through expanded teaching hours for children and adults in Chicago Lights' four computer labs, and they participated in the Fine Arts Festival of the Heart in the Cabrini-Green schools and celebrated the twenty-fifth anniversary of the Summer Day program. In the spring, they sponsored the Festival of the Artful Spirit, with a spring art exhibition showcasing both the work of COA members as well as the nationally acclaimed NARSAD work for and by persons affected by mental illness.

This exhibit sponsored by Chicago Lights brings together two collections that celebrate the themes of May: National Older Adults Month and National Mental Health Awareness Month. Additional 2006 exhibitions on display in the Loggia and Gallery include Sally Christiansen's images of those affected by AIDS in Africa, works by Marc Chagall and Ben Zion, Granite Amit, and artists with vision loss.



"Ed and Annette's Monkeys and More" return to Fourth Church Family Night on March 17. The St. Patrick's Day dinner is followed by an opportunity to learn about and pet a variety of animals—a monkey, chinchilla, fox, lizard, and large snakes.



"Welcome to the Fiesta!"—a celebration of Jesus' love—is the theme of this year's Vacation Bible School, held for a week during August. Junior and senior high youth contribute to the week's festivities by volunteering as station and crew leaders.





The Children and Family Committee recognizes two longtime Sunday School teachers, Marena Swenson and Nancy Wilson, during worship on Sunday, September 17. For nearly thirty years each, these two teachers have been giving of themselves to the children of this congregation and profoundly influencing their spiritual formation.

Children and Family

The Children and Family Committee is responsible for Christian education of children and youth through fifth grade. The Committee holds a baptismal seminar once a month for parents having their child baptized and oversees the Sunday morning nursery for infants through two years of age. The nursery is staffed by paid and volunteer workers. Sunday school begins at three years of age, and there are two sessions on Sunday mornings, with thirty-nine teachers who volunteer their time and talent. In 2006 Katv Sinclair, superintendent of the Church School, developed a comprehensive teacher manual for those volunteers. A four-week Academy for Faith and Life class provided additional resources for teachers and parents, supporting them in the role they play in the spiritual formation of the children they teach and parent.

Each Sunday, before Sunday School classes begin, Children's Chapel is held in Blair Chapel. The offering received during Chapel supports mission, and in 2006 it was given to programs in Cuba, Honduras, and Mexico.

The fourth and fifth grade Sunday School class continues to participate in the KISSE program (Kids in Sunday School Exchange), visiting other faith groups, who then also visit Fourth Church. In 2006, visits were made to a Baptist church and Quaker meeting. A yearly highlight for the class is teaching their parents the Sunday morning lesson.

The committee also continues to oversee two Fourth Church Family Camps a year at Presbyterian Camps in Saugatuck, Michigan. In the fall of 2006, participants made wreaths, which were made available during Coffee Hour the next Sunday, with donations collected supporting the CROP Walk.

The Day School, a preschool program under the direction of Ruthie Hornaday, served sixty-three children from two to five years of age, and the Children's Center, a full-time day care under the direction of Dana Micheli, provided care for fifty-three children from infants to five years of age. Both programs have NAECY accreditation.

Evangelism

The Evangelism Committee is charged with the responsibility of attracting and then shepherding potential members from the time that they first enter some part of the Fourth Church faith community until they make the decision to choose Fourth Presbyterian Church as their church home by becoming a member. New members begin their journey with this congregation in many different ways—through worship, Tutoring, the Chicago Avenue Community Garden, and the many other Fourth Church programs.

In 2006, 309 new members were welcomed into the fellowship of the congregation as a result of the commitment and hard work of more than 300 volunteers who provide points of contact, from greeters at Coffee Hour and open houses to Inquirers' Class teachers to Invitation Committee callers. The Welcoming Committee is often the first—and very positive—impression visitors have. Stanley Smith and his team are present during Coffee Hour on Sundays looking for and greeting visitors (many of whom are easily identified by the visitors' lapel pins available in the pew racks) and are crucial to the occasional sanctuary open houses, which attract more than 1,200 visitors a year. Through the gracious efforts of Welcoming Committee and so many members and friends of the congregation, Fourth Presbyterian Church is indeed a place of hospitality, welcome, and connection for visitors.

Mission


In 2006, the Mission Committee again facilitated the ongoing outreach of Fourth Church to its local and global neighbors. Travelers from Fourth Church continued to build relationships through mission trips to Cuba, Guatemala, Honduras, and the Pine Ridge and Rosebud Reservations in South Dakota. Mission Trip Sunday was held on World Communion Sunday in October to draw awareness to past and future trips. In an effort to build relationships with neighbors in Cabrini-Green, the Community Relations Committee planned monthly picnics in the garden and a dinner inviting Holy Family Lutheran Church. Among the various programs undertaken to build interfaith relations was an interfaith AIDS service coordinated by Fourth Church and held at Chicago Sinai Congregation. Also held was a Muslim-Christian Fellowship Luncheon.

The Multicultural Enrichment Subcommittee discussed and implemented initiatives to facilitate more inclusivity at Fourth Church. Community Ministry also partnered with a variety of neighborhood groups in efforts to, among other things, increase access to health care and social services and create a sense of community within the neighborhood.

In 2006, the Advocacy Subcommittee forwarded more than 1,500 letters signed at the Advocacy Table pertaining to issues of hunger, health, education, HIV/AIDS, gun control, immigration, domestic violence, and the environment. The committee also sponsored a well-received documentary film series the third Sunday of each month. A public forum was held in October in which gubernatorial candidates were invited to speak about their platforms on education finance reform.

Sixty-four nonprofit agencies received grants from Fourth Church Mission totaling \$150,000. For the second year, the committee also sponsored a Fair Trade Bazaar in Anderson Hall on the first weekend in December. This year more than \$30,000 was raised, which will provide jobs—and thus food and housing, education and health care—for twenty-five artisans from developing country and their families for one year.





Project Light

The year 2006 was one of continued progress and evolution for Project Light, the bold and strategic vision to ensure the future of Fourth Presbyterian Church and affirm its role as a "Light in the City." Project Light is a carefully developed and faithful plan encompassing four key initiatives: renovating and expanding the church's Michigan Avenue space for worship, programs, and fellowship; securing the future of mission and ministry programs by adding to the endowment; supporting pastoral theological education with a gift to McCormick Theological Seminary; and developing a community center on Chicago Avenue to better serve neighbors and to help bring about hope and understanding in that emerging and diverse neighborhood.

In January, work was begun on sanctuary improvements, with the ninety-year-old pews being removed from the sanctuary. After the flooring was replaced and cabling laid for the new sound system, new ergonomically correct pews were put in place, with new cushions and with pew ends that are exact replicas of the 1914 pews. Wood from the original pews was fashioned into small wooden crosses, which were made available to those interested in ordering them. Proceeds benefited Project Light.

The configuration of the pews and flexibility provided by wooden chairs on the side aisles provides greater access for those in wheelchairs and ensures compliance with the Americans with Disability Act, and the induction loop system, which is part of the newly installed sound system, is of great benefit to those with hearing difficulty.

At a special reception following worship on March 19, John Boyle blows out the candles on a cake celebrating his eightieth birthday. The occasion also marks the thirtieth anniversary of his ministry at Fourth Church, where he continues to serve on the staff of the Lorene Replogle Counseling Center, for which he was the founding director, and as a member of the pastoral staff.





Sanctuary improvements, undertaken as part of Project Light, bring new pews, new flooring, and a new sound system to the sanctuary. Work begins January 16, with the removal of the ninety-two-year-old pews, first installed when the Michigan Avenue sanctuary was dedicated in 1914. Temporary chairs are brought in each weekend for use during worship, and an electric organ is used to provide accompaniment for the services, as the pipe organ remains wrapped and sealed to protect it during the construction phase. All of the pews are in place by Sunday, February 26, and new pew cushions top off the project at the end of summer.

Woodworker David Trippel crafts keepsake crosses from the 1914 pews. More than 900 are made available to the congregation in two styles, a Celtic cross with carving detail and a simple cross without detail, each approximately 7" tall.











Thirty volunteers from Fourth Church join with others from the Near North Ministry Alliance in providing a day of food, learning, and entertainment at the Healthy Community Fun Fair in Cabrini-Green. More than thirty agencies are involved in this annual event, held at Seward Park, and together they offer information about health and safety. Children receive bike helmets, and the Chicago Lights Center for Whole Health does more than seventy blood pressure checks. Capping off the afternoon is a performance by the Jesse White Tumblers.

In 2006, the Chicago Avenue Community
Garden garden boasts 34 plots, attracts
59 regular gardeners and more occasional
green thumbs, and serves 24 children with
organized daily programs, with another 15
to 40 children at the garden every week for
other activities. Monthly cookouts draw 30
to 70 children and 50 to 150 adults for
fellowship, games, healthy recipe tastings,
and an afternoon meal.







As a result, Pathways Awareness Foundation honored Fourth Church with an Open Hearts Award in recognition of the church's efforts to provide access and inclusion in worship.

The Chicago Avenue Community Garden blossomed in its third year, with vegetables and flowers flourishing and, more importantly, neighborhood children and adults building relationships with each other and church volunteers. Structured children's programming at the garden included hosting Head Start classes from St. Matthew United Methodist Church and having six high-school interns from the Partners in Education summer job training program work with the garden staff. More than fifteen volunteer groups from across the country also spent time working at the garden during the spring, summer, and fall. Monthly cookouts at the garden helped build community among adults from the neighborhood and Fourth Church.

"A Light in the City: Sharing God's Grace," the Capital Campaign supporting the Project Light vision, continued to advance toward its \$30 million goal. Campaign pledge totals have reached more than \$24 million, and Project Light Leadership remains confident the goal will be reached, providing the critical funding necessary to bring Project Light to fruition.

The planned Joint Development, another important funding strategy for Project Light, has not yet come before the City Plan Commission. While it remains in the city process, the Project Light Leadership Team has been hard at work bringing their significant professional expertise and faithful vision to bear in exploring ways to press toward a date with the Plan Commission and a City Council vote; to look at ways in which the project might be redesigned to accommodate the material objectives of those in opposition to the plan; to examine ways to more effectively use the Chicago Avenue site—the site of the Community Garden and the future site of the Community Center—in the interim; and to look closely at what the most immediate space needs are and how they can be addressed most quickly and effectively. The leadership team fully anticipates resolution in the next year to building plans to provide desperately needed new program and mission space. The team also realizes that projects of this complexity do take time and patience, and all involved are committed to taking advantage of this opportunity to make some creative and bold decisions about the use of the resources passed on by preceding generations. As beneficiaries of these assets, this congregation and its leaders remain committed to passing on the blessings to those that follow, to being a faithful church, and to strengthening Fourth Presbyterian Church for generations to come, that it might continue to be a Light in the City.

Stewardship and Giving

The Stewardship and Giving Committee is charged with creating, implementing, and managing the annual Stewardship campaign, and in 2006, its role was expanded to include other Fourth Presbyterian Church programmatic fund-raising activities

Stewardship is a main component of giving at Fourth Church. The theme of the 2006 campaign, which kicked off in October 2005, was "You are a letter of Christ," based on 2 Corinthians 3:3. This passage symbolizes that living a Christian life means that everything we do in our lives is intended to represent Christ in the world, much like a letter. Through the Stewardship campaign, members of Fourth Church are asked to make commitments of financial support for the year. Careful and faithful stewardship of financial resources allows Fourth Church to plan and deliver the programs and mission outreach of the church. The 2006 Stewardship campaign was completed with a pledge total exceeding \$2.8 million and representing more than 1,200 households.

The goal for the 2007 campaign, which began in October 2007, is \$3 million. The committee plans to achieve this goal through a campaign that clearly states the specific program needs and desires of the church and that will substantially increase the number of participating households.

The Stewardship and Giving Committee also works closely with the Development Cabinet, the Joint Finance Committee, and Chicago Lights to strategically plan and schedule fundKraft Cares Day comes to the Elam Davies Social Service Center on Friday, January 13, as employees from Kraft Foods roll up their sleeves and get to work stocking the food shelves and decorating placemats for Sunday Night Supper. Through this annual event, Kraft Foods encourages its employees to participate in community service in honor of Dr. Martin Luther King Jr.'s birthday. In particular, the employees volunteer with



the organizations, such as Chicago Lights, that are recipients of the Kraft Employee Fund and the company's charitable contributions.

Since July 1999, more than 160 travelers from Fourth Church have built homes with Habitat for Humanity in Honduras. Moved by their experiences, those volunteers raised money to buy land so families who couldn't afford land could still have a house. In February of 2006, Dana Ferguson, Marc Miller, and Tom Schemper deliver a check for \$19,000 to Habitat Honduras, which is used to purchase land in Siguatepeque on which nine homes can be built for families in need. In July 2006, twenty-four people from Fourth Church help build five of those homes.



Fourth Church member and elder Linda Valentine begins the first year of a four-year term as executive director of the General Assembly Council (GAC), an election that is confirmed by the General Assembly of the Presbyterian Church (USA) on June 20. She now leads the GAC in advising the General Assembly on priorities, programs, and strategies for the ministry and mission of the PCUSA and implementing those at the national level.

Worship, Music, and the Arts

The coordination of the many worship opportunities at Fourth Church is at the heart of the work of the Worship, Music, and Arts Committee. The Committee and its members work with ushers and communion servers, musicians, lay participants, and pastors who lead and assist in worship services to provide faithful worship and preaching in the Reformed tradition and a warm welcome for the many who come through the sanctuary doors each week. Through the subcommittee of the Fine Arts Council, the Committee also provides for musical and artistic expressions beyond worship services to contribute to the life and work of the church.

In addition to four worship services on each Sunday, Fourth Church worships God in many alternative settings, including midweek services during Advent and Lent, daily Morning Prayer services to pray for members and friends, and a monthly Taizé service. Fourth Church also joins with other faith traditions in the annual Gospelfest in Cabrini-Green and the Interfaith Thanksgiving and New Year's Eve services.

Choral programs continue to develop for many ages and levels of experience, with the children's choir program growing in 2006. In addition to their leadership during worship, church musicians provided music performances, including the youth and children choirs' presentation of *The Rockslinger and His Greatest Hit*, the annual Tower Brass Christmas Concert, and a collaboration of the Morning Choir with the Dave Brubeck Quartet. During the month of July, Fourth Church was also pleased to host church musicians from throughout the United States and beyond for the biannual convention of the American Guild of Organists.

This year saw the completion of Laurie Wohl's "Unweavings" liturgical artwork, and regular art exhibits featured works by Marc Chagall, Ben Zion, the Guild for the Blind, and Granite Amit, among others. Fourth Acts continued to offer dramatic readings in and around worship services, and the

Fine Arts Council welcomed a special performance of the Gospel of Mark during Lent.

Youth Ministry

This past year was one of transitions for Youth Ministry at Fourth Church. For the first half of the year, the program was staffed by the interim team of Jessica Corlett Gregory (Junior and Senior High Fellowship), Liz Nickerson (Junior High Education), and Natasha Holbert (Coordinator for Youth Ministry), all under the supervision of Donna Gray, Minster for Children and Families. Along with an outstanding assembly of volunteer leaders, this team faithfully shepherded Fourth Church's youth during the search for a new Associate Pastor for Youth Ministry. In June, John Vest was called to fill this position and hit the ground running in July. Building on the past and planning for the future, the Youth Committee is working hard to create a vibrant program for youth at Fourth Church.

Although it was a year of transition, 2006 was also an eventful year for the youth. Twenty-two eighth graders joined the church through confirmation in May. Fourteen youth and three adult leaders traveled to Bloomington, Illinois, in June to help at the Illinois Special Olympics for the Junior High Work Camp. The Senior High Work Camp took twenty-one youth and five adults to Washington State in early August for various service projects in Seattle and the Yakima Valley. August also marked the installation of a new mural in the Crow's Nest and a redesigned web presence (www.fourthchurch.org/youth/index.htm). Fall programming kicked off in September with a full calendar and renewed energy.
